Privacy Policy

Under no circumstances do we sell or rent this information to other businesses, and we strictly protect and enforce the confidentiality of this information. We respect your privacy and seek to protect the trust you place in Jeff Georgi & Associates, LLC. Our Privacy Policy is explained in more detail below.

1. What information does Jeff Georgi & Associates, LLC collect from our online visitors?

For those individuals who visit our site, we collect and store IP ("Internet Protocol") addresses during the visit. No individualized information is collected, and the IP address is not traced to a particular individual. Similarly, we collect information, using that IP address, about the navigational or browsing activities of our visitors. Again, that information is not tied to any name or other personally identifying information but is used solely to provide generalized demographic data, such as what geographic areas our visitors are from and visitor browsing patterns. We cannot use that data to identify you. For those who make contact with Jeff Georgi & Associates, LLC, we collect and store your name, address and email address information.

2. Does Jeff Georgi & Associates, LLC use "cookies"?

"Cookies" are small pieces of information that are stored by your browser on your computer's hard drive. Most web browsers automatically accept cookies, but you can usually change your browser to prevent such acceptance. We do not retain any individualized information as a result of our use of cookies.

3. How do we use the individualized information that we collect?

We also retain your name, address and email address information in our visitor database. We use that information to respond to your inquiries and questions. We also may use that information, from time to time, to contact you. We try to limit those contacts to ones that might be of interest to you.
